  - 1) Cash or Cashier's/Manager's Check issued by a Universal or Commercial Bank, or **10% of Contract Price**
  - 2) Bank draft/guarantee or irrevocable letter of credit issued by a Universal or Commercial Bank: Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank, or **10% of Contract Price**
  - 3) Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security. **30% of Contract Price**

All of which form part of the Contract Agreement in accordance with the Bidding Documents. You are also required, within the said ten (10) days, to formally sign the Contract Agreement.

Your failure to comply with these requirements shall constitute a sufficient ground for the cancellation of this award and the forfeiture of your Bid Security.
